



LIMITED TRIAL TERMS AND CONDITIONS

1. Informa hereby grants to the reader of these Terms and Conditions a limited, non-transferable, non-exclusive, non-assignable object code license (i) to Use the software on a seven (7) day trial basis ("Authorized User") for the Authorized User's internal use and evaluation purposes only and (ii) to use the related Software user manuals and user guides (the "Documentation") provided as part of this trial, and (iii) to use the Data provided as part of this trial. The seven (7) day trial begins upon the Authorized User's acceptance of these Terms and Conditions.

2.1 Restricted Use. The rights granted herein are limited to Authorized User's internal Use of the Software and the Data. "Use" shall mean the ability to run, execute, display, and distribute internally the Software. Authorized User's shall not, and shall not permit any third party to distribute, sublicense, or otherwise make the Software or the Data available to any third party, including any affiliates of Authorized User.

2.2 Authorized User shall not, and shall not permit any third party to, translate, reverse engineer, decompile, recompile, update, or modify, alter or enhance all or any part of the Software or the Data, or merge the Software into any other software.

2.3 Authorized User agrees not to remove any existing copyright, serial number or proprietary rights legends which appear on the Software or the Data. Authorized User acknowledges that it obtains no rights other than those expressly stated herein. Except as explicitly provided in Section 1 of this Agreement, no license under any patents, copyrights, trademarks, trade

secrets, or any other intellectual property rights, express or implied, are granted by Informa to Authorized User under this Agreement.

2.4 Ownership of materials. All patents, trademarks, copyrights, trade secrets, and other proprietary rights in or related to the Software or the Data are and will remain the exclusive property of Informa or Data Provider, as appropriate, whether or not specifically recognized or perfected under the laws of the jurisdiction in which the Software is used or licensed. Authorized User will not take any action that jeopardizes Informa's proprietary rights or acquire any rights in the Software or related materials.

3.0 Term and Termination. Access to the Software will automatically terminate at the conclusion of the trial period. However, nothing shall prevent Informa, at its sole discretion, from terminating access at any time without cause and without notice.
